

# Minutes of the Roos Parish Council Meeting held in the Memorial Institute, Roos on Monday 10<sup>th</sup> July 2017

Present: Cllrs D Winter (Chair), J Cracknell, M Devanney, L Pearcey and K Tyson.

Apologies for absence were received from Cllrs W Ainley, A Dodson and M Maltas.

The Chair welcomed Cllr Pearcey who was attending her first meeting following her recent co-option onto the Council.

## **1. Consideration of Councillor's declaration of interests**

There were no changes declared by members to the register of interests.

## **2. Minutes of the meeting held on 12<sup>th</sup> June 2017**

These were agreed as a true record and signed by the Chair.

## **Matters arising from the minutes**

### **3. Overgrown hedge on local path**

A reply from ERYC confirmed that the hedge on the path bordering Beechwood Views had been inspected and as the path is classed as a public right of way rather than a highway the matter had been passed to the Countryside Access Team for attention along with photographs of the offending hedge.

### **4. Roos Beck**

The Chair reported that riparian owner Mr Grant had recently been active with a digger maintaining his section of the watercourse and that the beck appeared to be flowing without any apparent obstructions.

### **5. Highway matters**

A reply from ERYC indicated that potholes/surface cracking in the vicinity of the Memorial Institute would be inspected and any works required would be undertaken and it was noted that areas had already been marked up for attention. The reply also indicated that the provision of kerbs nearby on South End would be considered when funds became available and the request for a slow roundel on the carriageway at North End could not be granted as there was no evidence of there ever being a slow marking at the location in the past.

### **6. Proposed bus stop**

The Chair reported that he had met with ERYC on site at Pilmar Lane in connection with the proposed siting of a bus stop for the benefit of mainly Eastfield Estate residents and that ERYC would be undertaking a consultation exercise on the matter together with one for the provision of a further bus stop in Main Street.

### **7. Memorial service**

An invitation was received from Withernsea Town Council for members to attend a service to mark the 75<sup>th</sup> anniversary of the Withernsea air raid of 1942 in St Matthews

Church on the 22<sup>nd</sup> July at 10.30am followed by a wreath laying ceremony in the Memorial Gardens with refreshments afterwards in the Meridian Centre.

### **Planning**

Display of a non-illuminated notice board with 2 lockable A2 display cases at All Saints Churchyard Rectory Road Roos -17/01790/PAD

Erection of garage/store following demolition of existing garage and storage area at Westside Main Street Roos -17/01840/PLF

Erection of 11 dwellings following outline permission 13/03138/STOUT (scale, appearance and landscaping to be considered) at land north of Eastfield House Pilmar Lane Roos -17/01990/STREM

It was agreed that no objections be made to the above three applications.

Decision – Continued use of redundant agricultural building as commercial garage at land and buildings north of The Elms Quaker Road Owstwick

It was reported that ERYC had approved the above application.

#### **9. Coastal erosion**

Cllr Cracknell advised members that erosion north of Tunstall towards Hilston had been of the order of 40 metres within the last seven years and that she was seeking further details from officers at ERYC and would update Council when she had further information to hand.

#### **10. Dog fouling**

Concern was expressed of fouling particularly in the vicinity of Beechwood Views and it was accepted that the ideal deterrent would be for offending dog walkers to be reported to ERYC for possible prosecution by that Authority.

### **Public session**

A member referred to the possibility of ERYC providing “No footpath” signs on Rectory Road north of Hodgson Lane which was under consideration by that Authority in 2016 after a request from the Council and it was agreed to follow this up with the Area Engineer.
